TRAVEL TERMS AND CONDITIONS: (Please read everything carefully and initial each page)

Oassence Luxury Travel Designs and Travel Edge Travel Advisors will be referred to as the "Travel Advisors".

RESERVATION INFORMATION AND CONDITIONS: A non-refundable deposit of \$1,376CAD is required at time of booking to secure a space. An invoice, detailed pre-departure information, "what to bring" information and a personalized itinerary will be sent to you prior to departure. The balance is due 90 days prior to trip departure. Prices are based on a "double share" and a limited single supplement option is also available. Accommodations at selected properties may consist of one king bed only, with a limited option of two twin beds. This tour is not suitable for individuals under the age of 18.

PAYMENT SCHEDULE OPTIONS: Payments may be paid in full at time of booking, monthly or as per the payment schedule. The credit card of the traveller(s) will be automatically charged. The "Travel Advisors" will send a reminder of payments due approximately two weeks in advance of the payment due date via email only. The date of payments is determined by the date of receipt by the "Travel Advisors". If you do not meet the conditions of your payment plan, your tour reservation will be cancelled (subject to standard cancellation policy). Payments rejected due to insufficient funds, disputed by your credit company, returned to us by the drawer's bank, or returned due to a stop-payment order are subject to a \$35 non-refundable fee. We reserve the right to cancel reservations for any participant who does not meet his or her contractually obligated payment schedule. Payments are held in a trust account until the tour departure.

CANCELLATION: Land cancellation fees (days prior to commencement of land based tour November 12, 2020): Before the tour begins, the "Travel Advisors" reserves space for each enrolled traveller and thus incurs costs. For this reason, we must charge cancellation fees. To protect your travel investment in the event you need to cancel your tour, the "Travel Advisors" strongly recommends purchasing travel protection. Cancellations need to be submitted in writing on or before 61 days prior to departure. The following cancellation policies apply:

RESPONSIBILITIES OF TRIP MEMBERS: Participants have certain responsibilities to the "Travel Advisors" and to other trip members. Each traveller is responsible for understanding the conditions implied in the trip itinerary and committing to the trip so that it is appropriate to their interests and abilities, and for preparing for the trip by studying the trip itinerary and supplement provided. The "Travel Advisors" reserve the right to terminate the tour for any person or persons who are abusive of others or whose behavior disrupts the tour.

PASSENGERS WITH DISABILITIES: Any disability or allergy requiring special attention should be reported to the "Travel Advisors" at the time of booking. We will make reasonable attempts to accommodate special needs, but we are not responsible for any denial of services by carriers, hotels, restaurants, and other independent suppliers. Travellers requiring extraordinary assistance must be accompanied by a companion who is capable of and totally responsible for providing the necessary assistance.

INSURANCE: Out of country health insurance is mandatory and trip cancellation/interruption is highly recommended. We offer a comprehensive All-Inclusive Insurance Package, which includes medical and cancellation/trip interruption insurance; and a Trip Cancellation / Interruption Insurance Package. PASSPORTS AND VISAS: All participants are required to have a valid passport that must be valid for 6 months beyond the completion of the trip. Expiry date must be no less than May 21, 2021 and must have sufficient blank pages for all necessary entry/exit stamps. There are no visa requirements for Canadians travelling to South Africa however, the countries you are visiting have the right to refuse entry even if the required information and travel documents are complete. For those extending your trip beyond South Africa, you are solely responsible for any visas and/or additional documentation they may require. This is dependent on nationality and for entry into the countries visited or transiting through. Please consult your Travel Advisor for additional information.

TRAVEL VACCINATIONS: It is recommended that all travellers consult a health care professional or visit a travel health clinic preferably six weeks before the departure date to discuss options or any recommended medications and/or vaccines for travel to South Africa. Any inoculations and/ or medications that the traveller chooses or does require, would be at their own expense. Any legal proceeding which is properly subject to the jurisdiction of Canada and any Canadian province must be instituted on the pain of nullity in the judicial district of Ontario exclusively, and within six months after the return of the passenger from their Finest of South Africa trip.
